

A Pollution Prevention Collaboration among the Adams-Clermont Solid Waste District, Hamilton County, Butler County, Recycling and Solid Waste Districts, and the Ohio EPA

The Southwest Ohio Pollution Prevention (P2) Internship Program is a summer internship program that pairs college interns with companies in Adams, Clermont, Hamilton, and Butler counties seeking new and innovative approaches to environmental efficiency and conservation. Currently, we are accepting intern applicants for **Hamilton Safe by Gunnebo**, which is our 2024 host company in Clermont County.

About Hamilton Safe:

Located at a newly-constructed 180,000 square feet facility in Union Township, Clermont County, Hamilton Safe is a large scale manufacturer of physical security needs, including vaults and vault doors, bullet proof windows, pneumatic tubing systems, night depository drops, and safes of all sizes.

Hamilton Safe is owned by Gunnebo Holdings, a Swedish based global security company with high sustainability targets and standards. Driven by stakeholder's demands and in preparation of the Corporate Sustainability Reporting Directive in the EU, every entity owned by Gunnebo is responsible for thorough data reporting, as well as establishing and managing sustainability projects.

Intern Responsibilities:

The intern will be given responsibilities that will assist their learning and experience in implementing pollution prevention and sustainability initiatives, and will be required to attend a two-day pollution prevention training course prior to the start of site-specific project work.

During 2024 Hamilton Safe has two ongoing projects and a potential third project:

- Project 1: Collect and compile accurate data for scope 1, 2, and 3 emissions.
- Project 2: Establish product material composition data for all products, including material and weights used in production and used to ship products.
- Project 3 (potential): Research new materials and concrete formulations for use in vault panel, vault doors, composite safe, and composite doors product lines to reduce carbon footprint.

Requirements:

- Must be an undergraduate or graduate student with at least two years of undergraduate education completed
- Desired majors include: Environmental Health and Safety, Environmental Science and Studies, or Engineering
- Commit to working full-time for 12 weeks from May until August
- Provide own housing and transportation

Additional Desirable Skills:

Applicant must be detail orientated and have strong organizational skills. Proficiency with computer applications such as Word, Excel, PowerPoint and Outlook and the ability to utilize computer technology to research online, prepare reports, access and compile data and maintain records is required.

Work Setting:

Position requires work in a plant/manufacturing environment and intern will report to the job site during work hours. Environment may include fluctuations in temperature, dust, and noise. Required PPE includes safety glasses, safety toe shoes.

Drug screen and background check will be required.
